FUND PROFILE

The Taquanta Equity FR Fund is actively managed and aims to exceed the returns generated by the benchmark over a 3-year rolling period where portfolio position deviation from the benchmark is minimised. The portfolio is not a tracking fund, but will closely replicate the composition of the benchmark and aims to over time generate returns in excess of the benchmark by following a portable alpha investment strategy.


FUND OBJECTIVE

The objective of the portfolio is to produce enhanced returns relative to the benchmark over rolling 3-year periods where portfolio position deviation from the benchmark is minimised and to overtime generate long-term capital growth.

INVESTMENT STRATEGY

The portfolio invests in select combinations of equities, equity securities, equity securities listed on the Johannesburg Stock Exchange or listed and unlisted financial instruments. The portfolio will not invest in international equities, equity securities, international listed and unlisted financial instruments or in Africa (outside of South Africa).

MARKET COMMENTARY

The strength of US consumers, which has been reliant on the boost in savings from the pandemic era, seems to be coming to an end. Following the steady rise in the official unemployment rate, the total number of Americans collecting unemployment benefits rose for the 8th straight week, to 1.84 million as of the 15th of June 2024. This is the highest level in more than two years. Similarly, the US economic surprise index has also registered its most negative reading in 24 months, with policy expectations currently indicating possible rate cuts from as early as September 2024.

In the U.S., the S&P 500 index was up 3.6% m/m versus May 2024. The Russell 1000 value fell by 0.94% while the Russell 1000 growth index rose by 6.7% compared to the previous month. Similarly, the Dow Jones Industrial and Nasdaq grew by 1.2% and 6.3%, respectively, versus May 2024.

In Europe, the German DAX and the French CAC40 fell by 2.0% and 5.8%, respectively versus the previous month. Similarly, the Euro Stoxx 50 slid by 1.9% m/m, while the commodity linked FTSE 100 also fell by 1.2% versus May 2024.

According to Statistics South Africa, total employment decreased by 67 000 quarter-on-quarter, from 10 731 000 in December 2023 to 10 664 000 in March 2024 in South Africa. This was mainly owed to layoffs across the trade, community services, business services, and the mining sector. Similarly, gross earnings paid to employees fell by R35.1 b from R993 b in December 2023 to R957.9 b in March 2024. With nearly half of the working population unemployed, and the average household debt-to-income ratio north of 70 percent, policymakers remain poised to reduce real rates that have been on an upward trajectory since the peak of inflation back in July 2022.

In the month of June for South Africa, the political risk premium seems to have largely dissipated following the announcement of a new cabinet after more than a month since the ruling party lost its parliamentary majority in the May 2024 elections. The ALBI TR ZAR Index was up 5.24% m/m (and up 13.73% y/y), while the CILI TR ZAR Index rose by 2.94% m/m (and up 9.11% y/y). The JALSH TR ZAR Index rose 4.08% m/m (and up 9.14% y/y), while the JSAPY TR ZAR returned a positive 5.95% m/m (and up 26.25% y/y).

GLOSSARY

Net Asset Value (NAV): Means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.

Annualised Return: Is the weighted average compound growth rate over the performance period measured.

Highest & Lowest Return: The highest and lowest rolling twelve-month performance of the portfolio since inception.

Total Expense Ratio (TER): Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's

Transaction Costs (TC): Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.

Derivative Risk: Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
